## **RULES AND REGULATIONS:**

1. Artisans are required to check-in at 3:00 pm and be set-up by 4:00 pm on the day of the event. Artisans must be present the entire time of the show, 4:00 – 9:00 pm, and agree to be open during all hours. If an artist leaves early, they will not be invited back.
2. Booths are not transferable and may not be shared with other exhibitors.
3. Artists are responsible for providing their display including tents, tables, chairs, etc. We will give you a 10x10 space.
4. No tent stakes are allowed for booth set up or product display. Please bring sandbags to hold tent in place in case of wind. Please make necessary arrangements for your display.
5. No power or water is available at booth sites.
6. WIFI will not be available. Please make other arrangements to complete transactions.
7. There is no reserved artist parking. Main Street will be blocked off from South Miller to Locke Avenue so you may have to walk a few blocks to your booth.
8. Exhibitors are responsible for collecting and paying all applicable Sales Tax.
9. Please ensure your items are secure and someone is always available at your booth.
10. Tres Rios Habitat for Humanity and the City of Farmington are not responsible for any lost, stolen, or damaged items.
11. Exhibitors agree to allow the organizers of the event and any associates to use photos for marketing promotions. If you do not want your photos used, you must notify us ahead of time in writing.
12. Vendor cancellation: other than a medical emergency, with written documentation from your physician, there is no refund.
13. The Art Stroll Committee reserve the right to remove any vendors from their space for not following the rules, regulations, terms, and conditions set forth in this document and the Acceptance packet.
