### **RULES AND REGULATIONS:**

1. Set-up begins at 1:30 pm. We ask that vendors line up in their cars at the empty parking lots across from the Civic Center, 200 W Arrington St, Farmington, NM. Volunteers will direct you to your vendor spot on Main Street. You will be able to drive directly to your spot and unload. After the event, you also can bring your car back to your spot to pack up. We do ask that you park your car off Main Street during the event to make room for other vendors and cars.
2. There will be a few reservable spots available in Orchard Park for those with handicaps/physical disabilities. These spots are limited and available on a first-come, first-serve basis. All other vendor spots will be on Main Street between Allan and Orchard Street. If you are handicapped/disabled, please contact Cindi Haws at (505) 258-9273 or [habitatsanjuan@gmail.com](mailto:habitatsanjuan@gmail.com) to reserve a spot.
3. Please be set up by 3:00 pm when the event begins. Artists must be present the entire time of the show, 3:00 – 8:00 pm, and agree to be open during all hours. If an artist leaves early, they will not be invited back.
4. Artists are responsible for providing their own display including tents, tables, chairs, etc. We will give you a 10x10 space on Main Street, Farmington.
5. No tent stakes are allowed for booth set-up or product display. Please bring sandbags, or other appropriate weights, to hold your tent in place in case of wind.
6. No power or water is available at vendor sites.
7. WIFI will not be available. Please make other arrangements to complete transactions.
8. Exhibitors are responsible for collecting and paying all applicable Sales Tax to the City of Farmington.
9. Please ensure your items are secure and someone is always available at your booth. Tres Rios Habitat for Humanity and the City of Farmington are not responsible for any lost, stolen, or damaged items.
10. Portable bathrooms will be available on Orchard and Behrend Streets.
11. Exhibitors agree to allow the organizers of the event and any associates to use photos for marketing promotions. If you do not want your photos used, you must notify us ahead of time in writing.
12. Vendor cancellation: The vendor fee is non-refundable. Please notify us at least 48 hours in advance if you will not be able to attend.
13. The event organizers reserve the right to remove any vendors from their space for not following the rules, regulations, terms, and conditions set forth in this agreement.
